Self Financing Scheme (SFS) Class XI Admissions 2017-18: **(For Internal Students)**

Read the following instructions carefully before filling the registration form for the SFS admissions:

1. Duly filled in Application form with the required enclosures (Admit card Class XI entrance test/High School Marksheet, cash slip/DD of Rs. 100/- in favour of Finance Officer, AMU) shall necessarily be submitted to the respective Schools **Syed Hamid Sr. Sec. School (for Boys) and Senior Secondary School (for Girls)** on or before **05 August 2017**.
2. Internal students who have passed class X from AMU Schools in the year 2016-17 and appeared in Class XI (Science / Humanities / Commerce) / Diploma in Engg. Admission Test 2017-2018 are only eligible to apply for SFS.
3. If a candidate has been offered admission in XI – Science/Dip. Engg. in regular mode shall not be considered for Self Financing Mode of XI-Science. However, he/she will be eligible for XI-Humanities/Commerce provided the candidate has not been offered admission in regular mode of XI-Humanities/Commerce.
4. If a candidate has been offered admission in XI – Humanities/Commerce regular mode shall not be considered for Self Financing Mode of XI-Humanities/ Commerce. However, he/she will be eligible for XI- Science provided the candidate has not been offered admission in regular mode of XI- Science/ Dip. Engg.
5. The students admitted under SFS will have no claim for hostel accommodation or any other facility other than being treated as internal student.
6. Candidates seeking admission under the above scheme shall pay the fee notified by the university from time to time.
7. The classes under SFS will be arranged in the afternoon.
8. It is the responsibility of the candidate to visit the website www.amucontrollerexams.com regarding any admission related information.
9. Stream/School to internal candidates will be allotted through counselling. No upgradation is applicable.
10. Processing Charges of Rs. 100/- (as in point no. 01 above) can be deposited in the Canara Bank, AMU Branch, Aligarh / State Bank of India, AMU Branch, Aligarh.
