- 7 The last date to apply for re-evaluation of answer book of above mentioned course is 29 July 2023, and your application for re-evaluation should reach the Office of the Controller of Examinations latest by the said date.
- The result of Re-evaluation shall be final and binding on the candidate and no complaint or appeal against the revised award shall lie in any Court of Law, nor will the candidate claim any privilege deviating from the existing Ordinances, rules and regulations.
