- Candidates applying for re-evaluation shall have to surrender their original marks Certificate and photocopy of marks sheet with other separate application.
- 6. Candidates are required to use separate application form for each paper.
- The last date to apply for re-evaluation of answer book of above mentioned course is 05.9.2024, and your application for re-evaluation should reach the Office of the Controller of Examinations latest by the said date.
