

NOTICE

As per Ordinances (Academic) regarding re-evaluation notified vide D.No. XM/RE-EV/3989 dated 18.06.2020, the application for re-evaluation is to be submitted only in the **ONLINE MODE**. Students of the following Courses are advised to go through the above mentioned rules available on the website carefully before applying for re-evaluation:

1. B.Sc. (Hons.) Agriculture IV Semester Examination, 2018-19.
2. B.Sc.(Hons.) Agriculture I Semester Examination, 2019-20.
3. B.Sc.(Hons.) Agriculture III Semester Examination, 2019-20.
4. B.Sc.(Hons.) Agriculture V Semester Examination, 2019-20.
5. B.A./B.Sc./B.Com.(Hons.) V Semester (Non CBCS) Examination, 2019-20.

1. Student has to first login on the University website: www.amucontrollerexams.com and then register for re-evaluation.
2. Re-evaluation will not be permitted in more than one fourth of the total theory papers of the examination in which candidate has appeared.
3. There will be no Re-evaluation in case of practical, viva-voce examination, field work, Project work, Periodic Tests and Sessional of all the courses.
4. Application has to be submitted only in the **online mode** along with non-refundable requisite fee of **Rs. 300/- for each paper** for which re-evaluation is being applied. The student should keep ready his/her Net Banking/Debit Card/Credit Card details and follow the instructions available on the website to make payment.
5. The application for re-evaluation is submitted electronically the moment the student makes the payment of the requisite fee and payment is successful. There is no need to submit the hard copy of the Application Form.
6. No corrections are allowed after submission of online fee for re-evaluation. It should be kept in mind that the requisite fee for re-evaluation will not be refunded under any circumstances.
7. The last date to apply for re-evaluation for results of the above mentioned courses is **07 October, 2020**.
8. The result of Re-evaluation shall be final and binding on the candidate and no complaint or appeal against the revised award shall lie in any Court of Law, nor will the candidate claim any privilege deviating from the existing Ordinances, rules and regulations. A declaration to this effect shall be deemed to have been signed electronically by the candidate while applying for Re-evaluation.
