Sir,

I am directed to inform you that some colleges are approaching various Hon'ble High Courts. In W.P.(C)1539/2021 S.K.S. Ayurvedic Medical College VS Union of India, Ministry of AYUSH & Others and, in nine similar WPs, the Hon'ble High Court of Delhi vide an ad interim order dated 08th Feb. 2021, has permitted some colleges to participate in ongoing counselling process for the year 2020-2021 subject to the result of writ petition and the petitioners are directed to inform prospective candidates accordingly.

2. In other such cases also Hon'ble High Courts have issued interim orders but writ petitions filed by various colleges are still sub-judice.

In view of the above, it is hereby directed that in compliance of Hon'ble High Court's direction, all prospective candidates/students shall be explicitly informed in writing that their participation in the counselling process will be subject to the result of writ petition, filed by the respective institution/college.
