- Application has to be submitted in the <u>offline mode</u> only along with non-refundable requisite fee of <u>Rs. 300/- for each paper</u> for which re-evaluation is being applied. Every application for Re-evaluation must be submitted along with a Cash Receipt/State Bank Challan of Rs.300/-for each paper.
- 5 Candidates applying for re-evaluation shall have to **submit a copy of their online score card of I-Semester** in place of original mark sheet.
- 6 Candidates are required to use separate application form for each paper.
- 7 The last date to apply/submit re-evaluation form in the Office of the Controller of Examinations for the above mentioned course is 14.12.2023.
- The result of Re-evaluation shall be final and binding on the candidate and no complaint or appeal against the revised award shall lie in any Court of Law, nor will the candidate claim any privilege deviating from the existing Ordinances, rules and regulations. A declaration to this effect shall be signed by the candidate while applying for Re-evaluation.
