The Ordinances (Academic) regarding re-evaluation of answer books of Secondary School Certificate (Class X)/Senior Secondary School Certificate (Class XII) Examination 2019-20 have been notified vide D.No.XM/ORD/01 dated 31.07.2020; the application for re-evaluation is to be submitted only in the OFFLINE MODE. Students of the following Subjects are advised to go through the above mentioned rules available on the website carefully before applying for re-evaluation:

High School (Women Private) Main Examination 2024

1. Student has to first log in to the University website: www.amucontrollerexams.com and download the application for Re-evaluation of Answer-Books, available on following link <https://www.amucontrollerexams.com/uploads/files>
2. Re-evaluation will not be permitted in more than one fourth of the total theory papers of the examination in which the candidate has appeared.
3. There will be no re-evaluation of Answer-Books For supplementary/compartamental/re-sit/second examination viva-voce examination, field work, project work, periodic tests, online examinations, test and sessional of all courses.
4. Application has to be submitted in the OFFLINE MODE only along with a non-refundable requisite fee of Rs. 300/- for each theory paper for which re-evaluation is being applied. Every application for re-evaluation must be submitted along with cash Receipt/State Bank Challan of Rs300/-for each paper.
5. Candidate applying for re-evaluation shall have to surrender their original marks certificate and photocopy of marksheet with other separate application.
6. The last date to apply for re-evaluation of the answer book of above mentioned course is 19.01.2026, and your application re-evaluation should reached the office of the controller of examination latest by the said date.
7. The result of re-evaluation shall be final and binding on the candidate, and no complaint or appeal against the revised award shall lie in any Court of Law, nor will the candidate claim any privilege deviating from the existing Ordinances, rules, and regulations. A declaration to this effect shall be signed by the candidate while applying for re-evaluation.
