 4. Application has to be submitted in the **offline mode** only along with non-refundable requisite fee of **Rs. 300/- for each paper** for which re-evaluation is being applied. Every application for Re-evaluation must be submitted along with a Cash Receipt/State Bank Challan of Rs. 300/- for each paper.
 5. Candidates applying for re-evaluation shall have to surrender their original marks Certificate of Grade.
 6. The last date to apply for re-evaluation of answer book of above-mentioned course is **02.08.2025**, and your application for re-evaluation should reach the Office of the Controller of Examinations latest by the said date, failing which the application will not be considered.
