

4. Application has to be submitted in the offline mode only alongwith non-refundable requisite fee of Rs. 300/- for each paper for which re-evaluation is being applied. Every application for Re-evaluation must be submitted alongwith a Cash Receipt/State Bank Challan of Rs.300/-for each paper.
5. Candidates applying for re-evaluation shall have to surrender their original marks Certificate and photocopy of marks sheet with other separate application.
6. Candidates are required to use separate application form for each paper.
7. The last date to apply for re-evaluation of answer book of above mentioned course is **24.02.2024**, and your application for re-evaluation should reach the Office of the Controller of Examinations latest by the said date.
